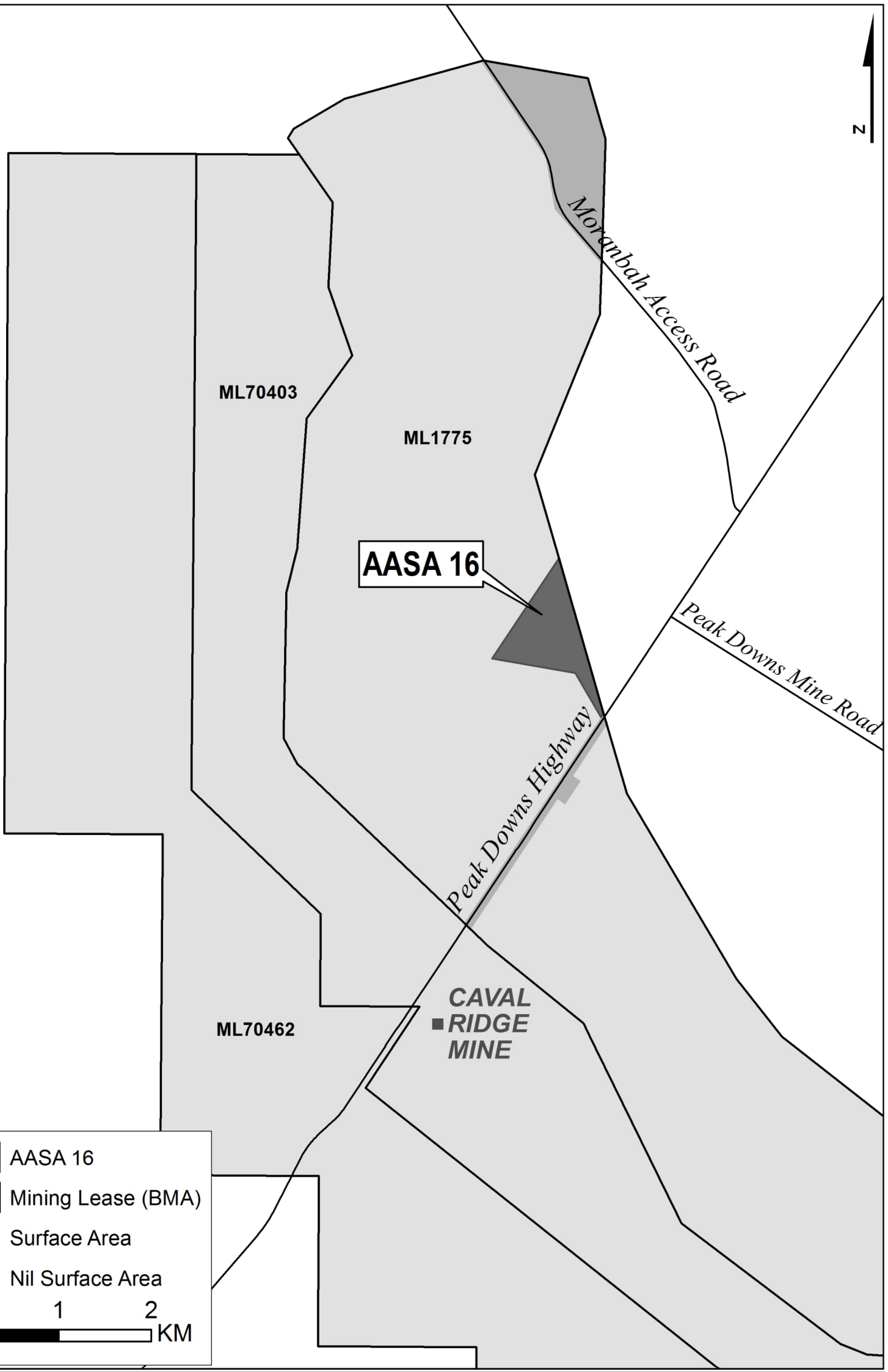
Submissions for the Environmental Authority application:
