### A message from Liz

A big hello and happy new year from me as we kick into 2025. I hope everyone got to spend the Christmas period with friends and family, doing what you enjoy. I had a few days of downtime and spent much of it on our property at Tenterfield.

At the end of last year, I was pleased to share with members of the Muswellbrook community the Closure Legacy Expectations Assessment (CLEA) Report. This report culminated a number of years of listening and engaging with the community to understand expectations around BHP's legacy in closure.

It's clear from the Report that the local community, like BHP, want the next chapter of Mt Arthur Coal to not only achieve positive environmental outcomes, but social and economic outcomes as well. We have continued to work on what might be possible with the mine land and infrastructure after 2030 to deliver on these outcomes. At this stage, we are considering the potential for pumped hydro, with a lot more work to do to enable other alternate land use options - including repurposing some of the existing infrastructure such as the workshops, office administration buildings and laydown areas. Our participation in the NSW Parliamentary Inquiry on beneficial post mining land use last year, saw us put forward what we see as the opportunity for land re-use when Mt Arthur Coal closes. This aligns well with the feedback that we received from the CLEA in that community want to see more than rehabilitation and environmental outcomes in mine closure.

I spoke a lot about these plans at the Upper Hunter Mining Dialogue Community Forum late last year, and the team and I continue to talk about these plans while we're out and about. In 2024 we got along to the Singleton Show, local business chambers and hosted our own Supplier and Contractor Forum to continually share our thinking. We will continue our regular updates this year and encourage anyone looking for more information to come along.

At the back end of last year, I travelled to Japan to visit Mt Arthur Coal's customers to provide insights on how we are thinking about transition and closure and to provide confidence in our ability to continue to deliver a quality product through until 2030. Mt Arthur Coal's relationship with customers in Japan is critical to deliver the aspirations we have set in mine closure so it was great to get over there and talk through how we will continue sustainable productivity over the next five years.

Looking forward, 2025 is set to be a big year for us. We anticipate a decision on the Modification to continue mining

beyond 2026 as part of a responsible closure of the mine in 2030. We have continued to work with the Department and respond to their enquiries over the last

little while. We will share any updates with you as soon as we can.


#### About Upper Hunter Community Services




Understanding community insights and expectations is critical to achieving a successful closure and transition of Mt Arthur Coal.

- access free financial advice sessions with Mine Super
- access career coaching and support to develop an individualised pathway to 2030 and beyond.

We launched this policy at the back end of 2024, and already it's had a great impact with over 300 employees taking up financial advice.
